

# **OUTRIGGER RENTAL EQUIPMENT TERMS AND CONDITIONS**

PLEASE READ THESE TERMS AND CONDITIONS IN ITS ENTIRETY! THEY CONTAIN IMPORTANT INFORMATION THAT AFFECTS YOUR RIGHTS, ABILITIES, AND OBLIGATIONS. THEY INCLUDE AN AGREEMENT TO RESPECT AND ADHERE TO OUR TERMS (UNLESS YOU OPT OUT, IN WHICH YOU WILL BE REFUSED ACCESS TO USE OUR PLATFORM).

These Terms constitute an "Agreement" between you and Outrigs (each a "Party" and together, "the Parties").

As an equipment owner listing your equipment for rent on Outrigs (an "Outrigger") you agree to provide safe, operable, reliable, and legal equipment to our renters ("Clients"), as outlined in the conditions below.

All equipment listed on Outrigs must be in safe working order. This includes, but is not limited to

1. Tires and wheels must be matching, leakless, mounted securely, and straight. Tires must always maintain the recommended air pressure. Tires must be free of any cuts or gouges that could cause air leakage. All axle nuts must be tight and secured by cotter pins, and wheel nuts must be torqued appropriately.
2. Controls and cables (such as brake, throttle, and clutch cables) must be operable and free from any sticking or stiffness. Controls must work smoothly. Throttle and cables must move smoothly and snap closed with the handlebars in any position. All brakes must brake appropriately and are adjusted according to the owner's manual. Foot shifter, if applicable, must be secure and positioned for safe operation.
3. Lights and electrics must all be operable. Ignition switch, if applicable, must work properly. The engine stop switch must work properly. Headlights and taillights must be operable and have working bulbs.
4. Oil (engine, gear, and transmission) and fuel levels must always be at appropriate levels before the equipment is picked up or delivered to a Client. Equipment must not have any fuel or oil leaks. Air and fuel filters must be in fair condition, with no tears or blocks.
5. All chains and driveshafts must be in safe and operable shape, maintained and lubricated on a regular basis. Chassis must be solid, with no cracks, breaks, or loose or missing bolts or nuts. Chains must be adjusted and lubricated regularly. Drive shaft must not have any oil leaks.

All equipment listed on Outrigs must be legally owned and registered by you, the owner.

If any negligence in providing a safe and operable, detailed in this Agreement, and legal equipment result in interfering with a Client's rental, including fees, fines, being stranded, or unable to operate equipment, you, as the owner, agree to refund the Client the rental fee, pay any fines or fees related to non-registration or non-ownership, and will compensate the Client up to \$500.00 US Dollars for major inconveniences, if deemed necessary.
